## Planned bridge closures to reduce traffic in your local area

We're making changes to local neighbourhoods as part of our ambitions for safer, cleaner and greener neighbourhoods.

This includes installing better walking and cycling facilities in neighbourhoods to meet rising demand and reducing levels of traffic using quiet streets by closing small bridges.

## The bridges include:

- Salters Bridge, Parklands ward
- Dene Bridge on Castle Farm Road, Dene and South Gosforth ward
- Haldane Terrace Bridge, South Jesmond ward
- Argyle Street Bridge, Ouseburn ward
- Stoneyhurst Road Bridge, Dene and South Gosforth ward

All the bridges are key routes for people walking or cycling to local schools or amenities but suffer from high levels of traffic cutting through residential streets rather than using more appropriate routes. We want to reduce levels of traffic in residential areas and by closing off these routes, we can stop unnecessary traffic from driving through local streets.

We are using Experimental Traffic Regulation Orders for closing the bridges. The legal orders will be operational from 13 August. Public consultation will be in place for six months. Argyle Street Bridge provides a link over the East Coast Main Line between Newbridge Street and the Ouseburn area of the City. The route provides a key link between the Ouseburn and the City Centre, as well as providing access towards Northumbria University from recently developed student accommodation in the area.

We are using experimental traffic regulation order to close this bridge to vehicles. This will be operational from 13 August 2020. The bridge will remain open to people on foot and on bikes providing a safe and convenient route for people using active modes of transport for journeys in and around their local area.

Under an experimental traffic regulation order, the first six months of the closure is for public consultation. During this time, people can leave feedback and comments on the closure, and these will be considered before a final decision is made on whether or not to make the changes permanent.
